

# Music Et Video Licensing

It is important to be aware of the legal requirements regarding the use of copyrighted materials when using and displaying music and video at your events and worship services.

## **Music: CCLI License and OneLicense**

Christian Copyright Licensing International (CCLI) and OneLicense allow you to copy and display songs, hymns, and lyrics by publishers listed in the license agreement for use in bulletins, slide shows, overheads or song sheets. We can also create musical arrangements of songs if other arrangements are not available.

If you use songs outside of our hymnals, you may want to continue using your **CCLI License**. The Community of Christ Worship Office strongly encourages the purchase of **OneLicense**, which provides coverage for many of the hymns with publishers such as all Taize songs, Augsburg Fortress, GIA, Mennonite World Conference, Presbyterian Publ. Corp., United Methodist Publ. House, and many more that are in *Community of Christ Sings!*

1. Apply for a CCLI License at **1-800-234-2446** or **www.ccli.com**. Cost of a license ranges from \$59-\$124 per year, depending on the size of your congregation.
2. Apply for OneLicense at **1-800-663-1501** or **www.OneLicense.net**. Cost of a license ranges from \$75-\$145 per year, depending on the size of your congregation.
3. Notify Mission Center Music Specialist **Mary Richardson** of your license number and the name of your congregation's license administrator (253-845-4855, **mrichardson@cofchrist-gpnw.org**).
4. If the publisher of the music is listed in your license agreement, place the following information on the music:

**Title of Song**  
**Words and Music by John Smith**  
**© 1975 John Smith Music Co.**  
**CCLI #1234567 or OneLicense #1234567**

5. If the publisher is NOT listed, you must call them for permission. However, there are some restrictions to using music not covered by your license:
  - a. We may NOT use any of these reproductions for commercial purposes.
  - b. We may NOT copy music for choirs, solos or small group performances.
  - c. Only authorized language translations may be used.

## **Video: CVLI License**

Christian Video Licensing International (CVLI) allows for free showings of manufactured DVDs and videocassettes of motion pictures. Coverage includes playing just a few minutes of a movie all the way up to showing the full-length feature.

1. Apply for a CVLI License at **1-888-771-2854** or **www.cvli.com**. Cost of a license ranges from \$85-\$230 per year, depending on the size of your congregation and the Producer Package you choose.
2. Notify Mission Center Music Specialist **Mary Richardson** of your license number and the name of your congregation's license administrator (253-845-4855, **mrichardson@cofchrist-gpnw.org**).

NOTE: The Greater Pacific Northwest Mission Center purchases yearly licensing agreements which allow the lawful showing of music and video at Mission Center events. ***The mission center licenses do NOT cover individual congregational worships or events.***
